NARRATIVE

On Sunday 08/08/2010, ██████████ and Brendan Mess were both arrested after they assaulted several people at the ██████████ convenience store, located at the corner of Prospect and Hampshire. Officers arrived on scene and the 2 suspects had fled on foot, walking west on Amory St. When officers encountered the 2 suspects, both refused to comply with officers' orders and started to create a loud disturbance in the middle of the street. One suspect became combative and was exhibiting aggressive behavior towards officers. That suspect was actively resisting officers' attempts to take him into custody. After a brief struggle with both suspects, they were taken into custody.

On Sunday 08/08/2010 at 0255hrs, Officer Anthony Macone and I, Officer Kevin Co, were in patrol in Car 2. We were travelling east on Prospect St. and had stopped at the red light on Hampshire St. Our attention was drawn to the ██████████ convenience store where we observed several people arguing. We were approached by a female, later ID'ed as ██████████. ██████████ states she and her friends were just assaulted by 2 males and that they had just fled on foot. I observed one male victim to be bleeding from the nose and another male victim to be bleeding from the mouth. ██████████ states she had been pushed to the ground by one of the suspects. ██████████ describes the suspects as one being a "very tall" white male and the other ██████████. An unidentified witness states the 2 suspects fled west on Amory St. We drove down Amory St. and observed 2 people walking in the middle of the street, approximately 25 yards

away. Both were observed to be male parties and one was significantly taller. As we approached the 2 males, the shorter male (later ID'ed as [REDACTED]) was attempting to hide between 2 cars in a driveway. [REDACTED]

My attention was drawn to the taller white male, later ID'ed as Brendan Mess, who was walking away from me. I ordered Brendan to stop and he stated, "You need a warrant. Do you have a warrant?" I informed Brendan that I was investigating an assault that had taken place at [REDACTED] and that he matched the description of one of the suspects. I observed Brendan to be a white male, approximately 6'3, and well built. Brendan refused to cooperate and continued to walk away. I ordered Brendan approximately 7 times to stop walking away and produce identification, but he refused. Amory St. was very quiet, but Brendan continued to yell loudly that he was not going to cooperate and that I needed a warrant to stop him. Brendan suddenly stopped and turned towards me. Brendan stated to me, "What are you gonna do about it? I can knock you out if I wanted to, you know?" Unknown what his intentions were, I attempted to grab hold of Brendan's right wrist to control him. Brendan pulled away and attempted to walk away. At this point, Officer Macone arrived and attempted to gain control of Brendan. Brendan started to flail his arms and body and was able to knock Officer Macone to the side. I then twice attempted to grab hold of Brendan's left arm to take him to the ground, but he was able to pull away from me both times. Brendan now faced Officer Macone and I and he exhibited a fighting stance towards us. Officer Macone then sprayed Brendan in the eyes with his department issued OC spray. It was evident that the OC spray did not have any effect on Brendan as he continued to be aggressively resistant towards officers. Officers ordered Brendan to get on the ground and that he was under arrest, but he ignored the commands and continued to take up a fighting stance. Officer Nicholas Mochi arrived on scene and also ordered Brendan to the ground. I then grabbed Brendan's left arm and performed an arm bar takedown. While on the ground, Brendan refused to put his hands behind his back and was continuing to attempt to roll onto his back. Officer Mochi was able to strike Brendan's right side with his department issued PR-24. It was at this point that Brendan finally complied and was handcuffed by Officer Frederick Cabral. After Brendan was handcuffed, he continued to yell at officers stating that he can "kick all our asses" and that he was a professional fighter, UFC fighter, mixed martial arts, and boxer. Brendan's continued yelling brought many residents into the streets, looking at his aggressive display. As we were attempting to place Brendan into custody, [REDACTED] had walked up on the officers yelling. [REDACTED] was ordered repeatedly to get back and he was subsequently placed into custody by Officer Macone. Professional Ambulance arrived on scene to treat Brendan's eyes, and he was eventually cleared. Brendan and [REDACTED] were both transported to the station by Officer Bynoe. Both were booked by Officers Owens and Photopolous under the guidance of Lt. Lang.

Officer Macone and I went back to [REDACTED] where we met with the victims/witnesses. I spoke with [REDACTED] and she states the whole incident started when she and her friends were walking in the parking lot of [REDACTED]. A black Mercedes occupied by 2 females along with Brendan and [REDACTED] had driven by them. [REDACTED] states the Mercedes was driving too close to the group as it drove by so someone in the group tapped the car to warn them to "watch out." At this point, Brendan and [REDACTED] exited the car and confronted the group. The 2 females in the car left the scene. [REDACTED] was pushed to the ground by "[REDACTED]" which is [REDACTED]. [REDACTED] then proceeded to punch her friend [REDACTED] in the nose. "The taller white male" which is

Brendan then punched 2 of [REDACTED] friends, [REDACTED] and [REDACTED]. [REDACTED] did not sustain any injuries. [REDACTED] appeared to have suffered a broken nose and black eye. Professional Ambulance did arrive on scene, but [REDACTED] refused to go the hospital. [REDACTED] suffered a bloody lip and refused medical assistance while [REDACTED] did not sustain any injuries, but his glasses did break after they fell on the ground. [REDACTED] and [REDACTED] both witnessed their friends get assaulted and they tried to mediate the altercation to no effect.
